PRESIDENT'S REPORT

GRANT POVEY

SEASON 2021

Passion can be anything that challenges, intrigues and motivates you. Passion is the energy that keeps us going, that keeps us filled with meaning, happiness, excitement, and anticipation. Ultimately, passion is the driving force behind the success and happiness that allows us all to live better lives.

Tigerland is brimming with passion. From the Board and Executive team, to our coaches, players, medics, trainers, managers, volunteers and supporters – passion is the glue that binds us. It's the reason we head down to Revo Fitness Stadium to get involved in, and be part of, a vibrant community built on the foundations of connectivity and the pursuit of success.

Success can be measured in many ways. The best way to measure success is to define what it means and looks like to you, and then assess your progress against these goals. Naturally, winning Premierships is the ultimate measure of success for a football club but performing beyond expectation, bleeding debutants, creating a positive club culture and cementing a strong financial base are also key contributors to our club being successful. One of the greatest measures of our success was winning the Rodriguez Shield back to back, a credit to the whole club.

The Board, as custodians of the Club, are committed to ensuring ongoing success. Every decision debated and decided on, is for what we believe is best for the club.

The Board's vision has been unwavering:

1. To be the powerhouse club of the WAFL, on and off the field;

Tracking: Off the field, we have come from a position of peak debt of \$800k to having over \$200k of cash at bank. Our operating surplus for the 2021 season was circa \$250k.

Tracking: On Field, The Board stands strong in the belief we have one of the best coaches in the WAFL - Ashley Prescott. Since returning to the Club, Ash has made a huge impact and handled himself brilliantly. Ash and his coaching team have reviewed 2021 thoroughly, and with the players, they will be working hard to secure the number one spot for Claremont in 2022.

2. Invest in our Talent Pathway to ensure that 90% of our league side is comprised of players developed from within our zones;

Tracking: Achieved. 98% of the 38 players who played league were from our zone

3. Be a community hub for our local junior football teams;

Tracking: Strong community engagement with clubs within our district in the last 12 months, with over 1,700 junior football stakeholders training and playing games at Revo Fitness Stadium in 2021

4. Have sustainable, strong financial performance, with no debt.

Tracking: Achieved

The WAFL industry is envious of the quality of our Board. I take great pride in the fact that we have robust, honest discussions around the table and we are all prepared to listen to the views of others.

CHIEF EXECUTIVE'S REPORT

Footy is a numbers game – and whilst disposals, clearances and metres gained might be some key performance indicators on the field – other statistics are perhaps a little more relevant across the entire club. And they paint a pretty good picture of 2021 too;

- 49,377 was the average Channel 7 TV audience for Claremont broadcast games
- 22,635 People attended WAFL matches at Revo Fitness Stadium
- 12,985 People attended Functions & Events at the Club
- 2,411 Official Members signed up to support the Tigers
- 1,711 Junior Footballers from the local district trained or played at Revo Fitness Stadium
- 1,116 People Attended our Matchday Presidents Lunches
- 723 Parmi's were consumed on Thursday Nights at the Tiger Bar
- 347 Players between the age of 14 - 32 pulled on a Claremont Jumper and represented our club
- 98 is the percentage of home-grown players at the Claremont Football Club, a third more than any other club
- 30 was the number of votes Bailey Rogers received to win the Sandover Medal as the competitions Best & Fairest player
- 7 was the draft pick Fremantle used to select Claremont women's star Amy Franklin in the 2021 AFL W draft
- 4 Kegs of Espresso Martini were consumed at our annual Ladies Day function
- 2 Is the years in a row we have now claimed the Rodriguez Shield

Herb Williams 4/1/21

Player number 373 for Claremont Football Club. Herb played from 1950-1953.

Shirley McKee 5/1/21

Shirley, widow of Harold (McKee), a valued and long-time Ladies Committee and club committee member.

Keith Shimmon 8/8/21

Claremont Football Club player number 423, playing from 1954-1959. Keith is the father of Todd Shimmon, Claremont Football Club's former CEO.

John McIntosh

Player number 533 for Claremont Football Club, Simpson medal winner and runner up Brownlow Medallist in his years spent at St Kilda in the VFL.

Dr. John Harvey

Life member and club doctor from 1986-2002. John is father to Richard (Harvey), who has played 164 games for Claremont Football Club between 1993-2003.

Dr. Peter Tunbridge

A life member of Claremont, Club doctor from 1957-1984 and valued club committeeman from 1963-1967. Peter played 33 games for CFC between 1954 and 1956 as player number 418.

Ray Richards

Claremont player number 418, playing from 1959 to 1961. Ray was also a valued coach and pioneer for Claremont FC, bringing in several young players to contribute to the club premiership in 1964.

Dallas Dempster

A cherished life supporter of Claremont Football Club who contributed greatly to the rise in power of the Claremont Football Club in a decade of dominance from 1986 to 1996. Dallas was the inaugural president of the Patrons Club in 1976.

Henry Dempster

Henry, a respected player for Claremont Football Club during 1942 and 1943 played in the 'under age competition', now known as Colts. He was one of the first 'under-age players' to play for the League side when the WAFL changed the age restrictions for the competition.

FOOTBALL OPERATIONS MANAGER

KEPLER BRADLEY

After a couple of really tough years following the Covid-19 outbreak we managed to get a full season completed but not without a couple of scares. Our round 4 fixture against Peel Thunder was postponed due to another outbreak which ultimately led to a prolonged season and the grand final being played in October for the first time. Our pre-season started in December 2020 with a new coaching group led by Ashley Prescott, who did a terrific job in his first year in building relationships with the players and rolling out his game plan. We also had a number of new recruits and graduating Colts players, and whilst we walked away empty handed, to have all 3 grades (Colts, Reserves, League) finish in the top 3 and run deep into the finals was an outstanding effort.

Darren Harper did a great job helping our young Reserves group win 15 in a row and finish the home and away season on top after a pretty comprehensive loss to Swan Districts in Round 1. The disruption at the back end of the year with a number of byes over the last 6 weeks made it difficult for our players to gather momentum in the finals. Our first final against a very experienced Perth went down to the wire, losing by a kick after the siren and then we travelled to South Fremantle oval to play Subiaco in a preliminary final where the lead changed several times during the game and our inaccuracy and efficiency ended up costing us as we went down by 8 points. Jacob Blight can hold his head high after strong form in the finals. A number of players impressed throughout the season with Ben Elliott controlling the midfield and Sam Alvarez racking up the ball consistently on the wing. Alex Pearce used the ball well off half back, while Marc Boyatzis and Louis Passera regularly blanketed the opposition's best forwards. Cam Anderson provided speed all over the ground while Max Minear showed his marking and athletic ability as a tall marking player. The football played by the Reserves team late in the year certainly had a positive influence on where the League side finished on the premiership table.

Our League side started the season off well winning 8 of our first 9 games of the year with an attacking, high scoring style of play. The middle to late part of the year we showed some indifferent form but in saying this, the WAFL competition has proved once again that the competition is incredibly close and if you are off a couple of percent you can lose to anyone, as every side found out during this period. We finished the season 3rd on the ladder where we found ourselves playing South Fremantle at Fremantle Oval in the semi-final. We shocked the South Fremantle outfit with an exciting, direct and free flowing style of play which saw us 30 points up just before half time. A brave South Fremantle came out after half time and piled on 5 goals in the 3rd quarter to be within a goal of our Tigers. The last quarter was a see-sawing battle, it wasn't meant to be and we went down by 1 point and turned our attention to West Perth at home. The first half was electric with both sides fighting and scrapping for every inch, piling on the pressure around the football we went into the half time break 11 points down, knowing that we needed to start the next half a lot cleaner. The Falcons came out strong and took the lead out to 26 points halfway through the 3rd quarter until a resilient Tigers team piled on the next 9 out of 10 goals to win the

game and book in another preliminary final at Fremantle oval. Not scoring a goal in the first 3 quarters had us at 3 quarter time huddle 35 points down but the boys ground it out in the last, kicking 4 goals while keeping South Fremantle scoreless and eventually losing by 11 points.

A lot of positives came out of the year with Jack Buller playing every game and locking down a key position spot, and our midfield boasting some of the competition's elite with Oliver Eastland, Bailey Rogers and Jye Bolton continuing their great form. Up and coming midfielders Ben Edwards and Max Spyvee showed class through the midfield while Declan Hardisty was rock solid down back. Alex Manuel had his best season to date being a goal every week. Our dual captains Declan Mountford and Jared Hardisty showed incredible leadership in their first year in captaincy. In 2022 we look forward to seeing a fully fit Francis Watson, back from injury and dashing off the half back line; Timm House, who has committed to a full year with the club, which certainly strengthens our forward line; and Ronin O'Connor, whose elite attitude and standards has already had a positive impact on our young group.

- We had 6 state representatives- Callan England, Ben Edwards, Jye Bolton, Bailey Rogers, Lachie Martinis and Declan Mountford.
- Jye Bolton won his 4th Simpson Medal in the state game against South Australia.
- Bailey Rogers topped off a great year, winning the Sandover medal.
- Alec Waterman was pre-season drafted and Kalin Lane mid-season drafted.
- We won the Rodriguez trophy.
- Milestones achieved by Jye Bolton- 100 games, Alex Manuel- 50 games, Declan Hardisty- 50 games, Oliver Eastland- 50 games, Dylan Smallwood- 50 games, Lachlan Martinis- 50 games, Jack Lewsey- 50 games and Declan Mountford- 50 games.
- Retirees in Kane Mitchell, Anton Hamp, Tom Lee and Tom Ledger.

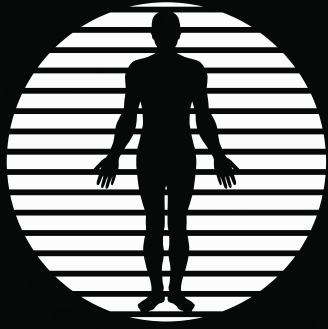

2021 has been another successful year for the Claremont Talent Programs, as we've continued our recovery out of last year's COVID-riddled season on the way to achieving some great outcomes. We returned to our full complement of four metro programs, which together with a range of regional pursuits, made for an exciting and fulfilling year.

WAFL COLTS

Some of the numbers behind this year's Colts team are truly astonishing – we played an enormous 63 players throughout the season, including 51 debutants, 8 players from our Great Southern zone and 10 from our Kimberley zone. These figures speak to what was a unique squad profile that promoted a theme of universal opportunity.

We finished the home and away season in second place with a record of 12 wins and 4 losses, despite losing three of our first five games. A 10-match winning streak followed, leading into a final round clash with top of the ladder Swan Districts who we hadn't faced since Round 1. Both games resulted in narrow losses, but we entered the finals series confident of being able to make an impression.

We commenced our finals series with an impressive 41-point victory over East Perth, to set up a 2nd Semi Final against Swans. Despite trailing for the entire day (at times heavily) until well into the last quarter, the boys displayed great spirit to produce an inspired final term that saw us progress straight to the Grand Final at Optus Stadium. Swans would go on to join us in the decider, having accounted for East Fremantle in the Preliminary Final.

Unfortunately, for the second year running we ended Grand Final Day disappointed, but unlike last year's comprehensive defeat, this was a battle for the ages where the lead changed hands consistently throughout the day in what many seasoned observers classed as one of the best games of Colts football they'd seen in a long time. Swan Districts were a formidable opponent with many even contributors across the ground – the fact that all four games between the two teams in 2021 were decided by a single-digit margin shows how close the battle was throughout the year.

As with every year, we had some standout individual performers throughout the season, with a full list of individual award winners and state representatives featuring later in this report. A few special mentions must be made though, starting with Angus Sheldrick, Jacob van Rooyen, Arthur Jones and Eric Benning who realised their childhood dreams in the 2021 NAB AFL Draft in late November.

All four boys were thoroughly deserving of their opportunities to join Sydney, Melbourne, the Western Bulldogs and Fremantle respectively, having each been on very different journeys to achieve their goal of being drafted. Their individual stories are celebrated further in an article later in this report. I wish all four boys the very best for their AFL careers that we look forward to following closely.

Also worth mentioning are the following players who were named in the 2021 WAFL Simply Energy Colts Team of the Year: Sean Williams (Back Pocket), Jacob van Rooyen (Centre Half Forward), and Angus Sheldrick (Interchange).

Finally, congratulations to the Top 3 in our Fairest & Best – Angus Sheldrick, Talon Delacey and Jacob van Rooyen. Gus put together a phenomenal season that saw him take out the Tom Richardson Trophy despite only playing nine games due to PSA and State Football commitments. Of those nine games he played, Gus polled in all of them, was voted Best on Ground in seven of the nine, and recorded three 'perfect' 25-vote games (two of which came in the finals). Indeed, his finals series will live long in the memory, battling through a significant cork to produce a range of inspirational moments, highlighted by kicking six goals across the three games.

The Colts Program does not run without the amazing work of many people. Thank you to Coach Matt Angus and his Assistant Coaches Ben Willett, Brendan Arundell, Brett Bowker, Ashley Clancy, Ryan Pontifex, Matt Sofoulis and Chris Bandy, along with Sam Wallace, Jake Colvin, Tom Morrison and 2020 Colts Captain Joel Western who made cameo coaching appearances throughout the year.

We owe plenty to our support staff, made up of Team Manager Bern Willett, Property Managers Jack Denton and Trevor Naulls, Head Physiotherapist Chloe Phelps, CFC Medical Team stalwarts Dr Lionel Lim and Anthony McEvoy, Head Trainers Katie Hanrahan and Kara Malkovic and their team, and finally Head S&C Coach Andrew Jonson and his Assistant S&C Coaches Jacob Smith, Tom Wright and Oliver Armstrong. These people put in significant hours for the benefit of the program and the players, and their efforts do not go unnoticed.

WAFL FUTURES

Our Futures group endured a challenging campaign, winning just the one game out of six, but showing some positive signs for the years to come regardless. At the end of the Futures Competition, we had Kai Dehavilland and Louis Tangney graduate straight up into playing in our Colts team the very next week, which is a rare occurrence but a challenge that they both managed admirably, going on to play seven games each throughout the season.

Congratulations to our 2021 Futures Award Winners: Encouragement Award – Joshua Howard, Tiger Award – Kai Dehavilland, Most Consistent Award – Aiden Riddle, MVP Award – Bailey Banfield and Emerging Talent Award – Daniel Curtin. Dan is also to be acknowledged for his selection in the WA State 17s Squad where we performed strongly as an underage player during their National Carnival.

Thank you to Coach Ashley Clancy and his Assistant Coaches Ryan Pontifex, Craig Rogers, Ritchie Hore, Ben Noakes, Ricki Smith and Scott Thornton, and Head S&C Coach Emmett O'Brien along with Marlee Hedley who covered in his absence for a period during the program.

DEVELOPMENT SQUADS

Our 14s and 15s Development Squad Programs edged back towards normality in 2021 with both programs involving training blocks before splitting into two teams to play games against other WAFL clubs during the school holidays. As always, we took a strong development focus into these programs (including on game days) that we hope will serve to benefit the players and the club in the long run.

One particular positive out of this year's Development Squad Programs was the buy-in of the young lads to the club as a whole. I've never seen so many of our youngest players down supporting the Colts and Seniors on Saturdays – particularly the 14s group who were really invested in our finals campaigns with the senior teams. This wider club culture is something we look forward to continuing to build on.

My thanks to our Development Squad Coaches; Craig Rogers, Ritchie Hore, Samuel Alvarez, Campbell Rogers, Lewis Daisley, Tony Fitzpatrick and Chris Tan. Special mention to Colts Assistant Coaches Ben Willett and Ryan Pontifex, who led the 15s Program this year, as well as our Development Squad S&C Coaches Jacob Smith and Tom Wright.

REGIONAL DEVELOPMENT

After a year full of cancelled events in 2020, it was great to see our regional academies bounce back this year, despite COVID still causing a few hiccups along the way, particularly in the Kimberley.



One of the highlights of 2021 was being able to take a Colts home and away game down to Albany in July. The match was played under lights in front of a big crowd at Retravision Stadium and served as a thoroughly enjoyable experience for all involved.

The Great Southern Storm were part of several terrific engagements throughout the year, including a Futures game against Claremont in Albany, the Great Southern Colts Carnival, a Regional 15s Development Squad Carnival, the Nutrien Ag Solutions Country Football Championships, and a 14s Development Squad game against Claremont at Revo Fitness Stadium. Through these initiatives, the connectedness of young footballers in the Great Southern to the Claremont Football Club continues to grow, which only means good things for us in the long-term.

The return of the Kimberley Spirit 16s and Colts Championships in modified formats in 2021 was really positive, as were the couple of opportunities we had to fly players and staff down from the Kimberley to play in representative matches in Perth. As mentioned, COVID still threw out a few plans we had for this year, so we look forward to developing our Kimberley engagements further during 2022.

ROGERS TRIUMPHS OVER ADVERSITY

Suffering from sesamoiditis, a painful affliction of the foot, and then fracturing his left knee as a teenager failed to discourage Bailey Rogers from his dream of developing into a quality footballer --- and he was rewarded for his perseverance and unswerving dedication by winning the Sandover Medal as the best player in the WAFL competition in 2021.

The 24-year-old Rogers joined the exclusive club when he became the 13TH Claremont player to win the Sandover Medal when he was recognised for his magnificent season by polling 30 votes which enabled him to win the prestigious award by three votes from his Tigers teammate and 2016 and 2018 Sandover medallist Jye Bolton.

Rogers capped his outstanding year by winning the E. B. Cook Medal as Claremont's fairest and best league player. His rise to fame coincided with his wonderful metamorphosis this year from a superb defender to a dynamic inside midfielder.

He was born in Bunbury and moved to Perth with his family when he was six, and in junior ranks with the Marist club and Claremont's development squads he played as a midfielder and as a half-back.

It was always a burning ambition to play as an inside midfielder. But most of his coaches in his early days admired his strength and ability to blanket forwards, and that resulted in Rogers being used mainly as a defender.

He made an excellent start to his career at Claremont when, as a 16-year-old, he played in a back pocket in the club's colts premiership side at Subiaco Oval in 2013. "We beat South Fremantle by a goal and some of my teammates that day were Darcy Cameron, Alec Waterman and Tom Barrass," said Rogers.

The Tigers colts lost the 2014 grand final to Swan Districts before Rogers had the honour as captain of the side which defeated Swans by 70 points in the 2015 colts grand final when his teammates included Waterman, Matt Guelfi and Declan Mouniford.

Rogers represented Western Australia at national carnivals for the 16s in 2013 and the 18s when he was vice-captain in 2015, the year in which he made his league debut in the round 21 match against East Fremantle at the Claremont Showgrounds.

"Memories of my first game will stay with me forever," said Rogers. "And I could have kicked a goal in my first game, but Jack Bradshaw was in the goalsquare screaming for the ball, and I handballed to him. I played at half-back as a lockdown defender, and I didn't have too bad a game and ended up with 14 disposals."

It wasn't always a bowl of cherries for Rogers in his early years at Claremont. He suffered a broken leg in a match at Fremantle Oval and was severely affected by a foot injury for about 18 months.

"I broke my leg on the far side of Fremantle Oval when I went up for a spoil and came down on my left knee," Rogers said. "It buckled and hyper-extended, and I was pretty lucky to get away with no ACL damage or a major tear. It was just a couple of fractures in the femur and a few strains which kept me out of action for a few months.

Rogers played in all 20 league matches in 2016 as a half-back flanker, and he finished fifth in the fairest-and-best award. A nasty knee injury resulted in him appearing in only six matches in 2017 before he had a break-out season the following year, during which he produced a remarkable performance in the round 12 match against East Perth at Leederville Oval.

He took 16 marks at half-back where he outplayed Nathan Blee, a former Port Adelaide AFL player and East Perth's fairest-and-best award winner in 2014 and 2017.



"That gave me a lot of confidence that I could play at the top level," Rogers said. "I never intended to be a backman for all of my career. I did an apprenticeship in the back line when I was young and was required for a few lockdown roles.

"I always wanted to be an inside-mid, even though I played on a half-back flank in my two matches for WA. They were great experiences to come up against the best in South Australia, and to play with the best players in the WAFL was also a great privilege."

Rogers was pencilled in for a midfield role for the 2020 season, but when Lachie Martinis was laid low by a serious ankle injury and was forced to miss the entire season, Rogers had to fill a role in defence.

As a team-first player, Rogers was happy with that outcome, but in the 2021 pre-season he was determined to cement a spot in the midfield and move up the ground and have an impact in the forward half.

Bolton proved to be a massive help in the Rogers transformation, with Rogers saying: "A lot of credit goes to Jye for where I am today. I think he pushed the coaches to give me a shot in there, and once I got into the midfield, he was the first one to help me out. He is a great one to go to for advice and he's always there, helping me with the stoppages, and he's always there, backing me in."

"Ash Prescott also has been a massive influence," said Rogers. "He gave me the chance in the midfield, and half-way through the year we sat down and spoke about things to improve on, and one of them was my fitness and weight.

"Ash put a plan in place and arranged for a dietician. I lost two or three kilos and that was a major part of my form in the second half of the season, being able to cover the ground a lot better than I had been.

"I was about 87kg at the start of the season when I was probably in the gym a bit too much. I did a bit more running in the second half of the season, and this helped my game."

Surprisingly, Rogers was overlooked at the AFL draft, a decision by the clubs that is difficult to come to terms with.

"I am at a great football club where I love every person," said Rogers. "So, if I am overlooked, I'll be more than happy to keep playing for Claremont."

TIGERS SHOW THE WAY IN AFL DRAFT

The Claremont Football Club maintained its standing as Western Australia's premier nursery of young players when four talented teenagers were snapped up in the 2021 AFL national draft in November.

Angus Sheldrick was selected as pick No. 18 by the Sydney Swans, Jacob van Rooyen was chosen as pick No. 19 by Melbourne, Arthur Jones was taken as pick No. 43 by the Western Bulldogs, and Eric Benning went at No. 54, chosen by the Fremantle Dockers.

This meant that Claremont was the best WA club in providing draftees, and the club also had the distinction of being the equal second most successful club in Australia, with the Sandringham Dragons showing the way with eight drafted players --- well ahead of Claremont, the Dandenong Stingrays and the GWV Rebels, with each club having four draftees.

Once again, Claremont's performance is testimony to the club's successful youth policy and development programs in both the metropolitan area and in its country zones of the Kimberley and the Great Southern.

Sheldrick and van Rooyen are products of Claremont's metropolitan development programs, with Jones hailing from Mt Barker and Benning from Kununurra.

Due to Covid-related travel restrictions Claremont's three young men drafted by Eastern States clubs will remain in Perth until January. Sheldrick will train with Claremont's senior squad in December, along with other Sydney players Logan McDonald and Chad and Corey Warner. Jones will also train with the Tigers, along with former Subiaco player and current Port Adelaide forward Mitch Georgiades.

Van Rooyen will join several Melbourne players at pre-season training with South Fremantle.

Sheldrick, a tough as nails inside midfielder and a fierce contested ball winner, has made giant strides this year after missing the entire 2020 season as he recovered from a fractured collarbone. He also made a late start to pre-season training as he fought off the effects of a bout of tonsillitis.

Last year it was considered by some that Sheldrick was too slow to graduate to AFL ranks. A firm believer that there is no substitute for hard work, Sheldrick responded by arranging individual training from a sprint specialist. Also, unbeknown to his colts teammates he got out of bed at six o'clock in the morning three times a week to go to the gym to work on improving his strength.

This was all part of his determination to succeed at football, and the former State junior hockey representative and water polo player revealed great character to manage himself in Year 12 at Christ Church Grammar School where he was a prefect and captain of the football team, as well as juggling his football commitments with the Tigers and State junior squads.



Not only was he Christ Church's fairest-and-best player this year, but he also was the fairest-and-best player for the Claremont colts, despite appearing in only nine matches. Remarkably, he was judged as his side's best player in seven of those matches, including the grand final against Swan Districts when, in the space of one minute in the third quarter, he snapped two goals, one on each foot from opposite pockets. That effort followed his three goals against Swans in a semi-final when he was badly hampered by a bruised leg.

A strongly-built 88kg left-footer, Sheldrick, who admits he has modelled his game on Luke Hodge, was one of WA's best players in two matches against South Australia this year. A fierce tackler and strong runner, Sheldrick was named in the 2021 WAFL colts Team of the Year. For the Tigers he averaged 26 disposals (16 contested), six clearances, four tackles and six inside 50s.

Van Rooyen is a prodigiously talented key forward, who revealed this year that he is also a highly capable defender. His competitiveness and wonderful aerial ability are his major strengths. He made his debut in colts football as a 16-year-old, and then was named at centre-half-forward in the WAFL colts Teams of the Year in 2020 and 2021.

Early this year he battled glandular fever and missed a month of football. He booted 34 goals in nine colts matches, including six against Subiaco and five against Perth before scoring 11 goals in three final-round contests. He got a taste of senior football in five league appearances for the Tigers when he produced some exciting moments as a forward. Impressive features of his game include his strong contests in the air and on the ground.

In the WA versus SA curtain-raiser before the AFL grand final at Optus Stadium van Rooyen played strongly in defence before giving further proof of his versatility by moving up the ground to kick the winning goal 56sec. before the final siren.

Jones, a willowy 65kg speedster, comes from Mt Barker and is closely related to the famous brothers Jim and Phil Krakouer. An athletic wingman with elite speed and endurance, he has shown that he is at home playing in attack and in defence where his run and carry makes him an extremely exciting performer.

He graduated from the Great Southern Storm program, and a lad with a bubbly, extroverted personality he stood out with his confidence and being the loudest character when he joined Claremont's development squads for 15-year-olds when many boys are introverted and quite shy.

At the start of the second term in 2020 Jones was awarded a scholarship at Wesley College, and after only a week he was added to the school's football team's leadership group. He then was vice-captain of the Wesley first 18 in 2021 and made ten appearances with the Claremont colts side when his best football was on a wing where his speed, agility and evasiveness became hallmarks of his game.

He sparked in an interstate contest against South Australia when he booted two goals and sent the ball inside the side's 50m attacking zone six times. He also shone with 16 disposals, including two goals, in the curtain-raiser before the AFL grand final.

Jones designed Wesley College's 2021 Indigenous jumper and the school's new Indigenous ties. He is looking forward to modelling his game on Western Bulldogs captain Marcus Bontempelli.

Benning is an athletic and agile high-leaping ruckman who has been a member of the Dockers Next Generation Academy this year. He graduated from the Kimberley Spirit program and is now studying for a Bachelor of Sports Science at the University of WA.

Softly spoken, humble and unassuming, Benning moved to Perth only last February and he certainly has considerable scope for developing into an exciting footballer.

He represented WA in three NAB under-19 championship matches, and in 13 colts matches he achieved 221 hit-outs. His outstanding third-quarter performance in the colts grand final against Swan Districts swung the momentum of the game in Claremont's favour.

Apart from his excellent work in the ruck Benning shone as a key forward with four goals in a round 18 match against Subiaco. His vertical lap and his agility are his major strengths, and he has the credentials to follow his brothers Shane McAdam (Adelaide Crows) and Ash Johnson (Collingwood) as a polished AFL performer.

MANUEL RISES TO THE CHALLENGE

Alex Manuel played at centre-half-back and full-back in his junior days and in a back pocket for the Scotch College first 18 a decade ago. But he always thought that playing as a forward was his natural position.

He enjoyed a good apprenticeship as a forward for the Claremont colts and reserves teams before graduating to senior ranks, lining up mainly as a half-forward flanker.

But at the start of the 2021 season, he was thrust into the role of Claremont's key forward, following the departure of Alec Waterman to Essendon and the retirement of Tom Lee.

It was a challenge he met with typical enthusiasm, and though not the archetypal tall, willowy full-forward, the strongly-built and skilful 26-year-old right-footer shone in attack, not only by kicking goals but by becoming an on-field general who helped to develop the younger players around him.

He lined up at centre-half-forward, on a flank, in a pocket and at full-forward and was the league side's leading goalkicker with a tally of 42.20 to boost his career total to 99 majors in senior ranks.

"My aim was to close the gap, particularly with the departure of Waterman, and to help the younger players to get better, as well as kicking a few goals," he said.

"I'm probably the Jack Gunston type of player, the third tall in the forward line, and trying to be difficult for the opposition to match. I try to lead hard at the ball and present at the footy. I concentrate on repeat leads, taking marks on the lead and stretching defenders."

Manuel is a strong high-marking player who also excels on the ground, and though he is an accurate set shot at goal, he scores many of his goals from kicks around his body, in a similar style to former champion Claremont player George Moloney, who scored 555 goals for the Tigers during his illustrious career in the 1920s, 30s and early 40s.

He is also cast in the mould of Jack Stewart, who scored many of his 319 goals from snaps around the body in his 109 matches in the 1940s and 50s. Manuel also excelled with between ten and 15 of his goals this season coming from clever left-foot shots.

"It is pretty handy to be able to kick goals with either foot when you get time and space," he explained. "Scoring with my left foot is something I have worked on."

Manuel said he learnt a lot this year from the club's forward coach, the 2007 Sandover medallist Anthony Jones, a former outstanding centre-half-back and centre-half-forward for the Tigers and the Fremantle Dockers.

"He worked with me at training when he stressed the importance of body positioning," he said.

Manuel said he was looking forward to playing in attack next season alongside Timm House, who played a handful of games late in the season this year. "We looked a lot more settled with him in the side," said Manuel. "And I was most impressed with the way Jack Buller played as a forward in his first season in the senior side."

Coach Ash Prescott praised Manuel for his efforts during the season, saying: "When I arrived back at Claremont there



were a few people who felt that Alex could offer a little bit more. So, we challenged him to get as fit as he could and given that he has a heavy workload off the field, we tried to individualise his training program as best as we could.

"He did that effectively with Anthony Jones, and they built up a great relationship, and they worked really well together. Timm House will be back, and there's good pressure coming through with the likes of Max Minear, Steve Miller, Jack Buller and young Dylan Mulligan.

"When Alex and Timm are in the team, they worked really well together and provided the young group with a bit of maturity and stability.

"Alex plays a mix of close to goal and a bit higher up the ground. I found him a pleasure to coach; he is a real team-first player who goes about his work in a very methodical fashion. He thinks about his football and brings others into the game and is very selfless.

"And then he has that ability to perform some wonderful skilful acts of football with his ability to find a little handball or execute a difficult kick and make a half chance into a six-point opportunity for the team. He is a strong player who leads at the ball very well, with good hands.

"Alex has that uncanny ability to know where the goals are. Often you are asked as a coach whether there is a player you would almost put your house on to kick a goal, and I think that Alex would be right up there with the players I have coached.

"That's a real credit to him because you will often see him before and after training, just by himself, spending 30 minutes, having 30 to 40 shots on goal from all different angles. It's no accident that he is able to produce under pressure and kick some pretty good goals."



A FOND FAREWELL FOR OUR RETIREES

Four long-serving stalwarts Kane Mitchell, Tom Lee, Tom Ledger and Anton Hamp have decided to hang up their boots after distinguished careers with Claremont.

This outstanding quartet leaves behind many joyous memories of their wonderful deeds on the football field. We admire them for their skill, their passion and their dedication.

From their combined tally of 485 WAFL league matches they have taken 2192 marks, had 4283 kicks and fired out 2733 handpasses.

Each of the retirees enjoyed a taste of AFL action, with Mitchell playing for Port Adelaide, Lee and Ledger playing for St Kilda, and Hamp being on the West Coast Eagles list for two years when he appeared in three NAB Cup contests. All of them returned to line up for the Tigers after their AFL stints.

Mitchell retires as one of Claremont's best players of this century. He was a fiercely competitive hard-working midfielder, a running machine with great endurance. Lee was a brilliant high-flying key forward, Ledger was a talented wingman, a prolific ball-winner with creative skills, while Hamp shone both as a key forward and key defender.

Mitchell, who celebrated his 32ND birthday on December 1 this year, and Tom Lee (30) were teammates in Claremont's league premiership sides in 2011 and 2012.

They were dominant performers in 2012 when Mitchell won the E. B. Cook Medal as Claremont's fairest and best player, and Lee was runner-up for the award. Mitchell also won the Sandover Medal, polling 58 votes to equal the record tally of Subiaco's Matt Priddis in 2006.

Lee, who polled heavily with 29 Sandover Medal votes, was Claremont's leading goalkicker in 2012 with 60 majors, including seven against Swan Districts in round 16 as well as four bags of six goals. He also booted six goals and was the best afield when Claremont defeated Werribee in the final of the Foxtel Cup.

Ledger (29) made an outstanding start to his career at Claremont in 2010 when he was a member of the WA 18s side and won the Jack Clarke Medal as the best player in the WAFL colts competition. He was then drafted by St Kilda and made his AFL debut in a round-11 match against Collingwood in front of a crowd of 65,000 at the MCG in 2011.

He made eight AFL appearances and played 45 games for Sandringham in the VFL competition before he returned to Claremont in 2014 when he made his league debut in the round one match against Perth at Lathlain Park.

Ledger had the uncanny knack of reading the play and knowing where to go to win the ball which he invariably delivered with precision with either foot. He suffered a serious knee injury early this year which kept him on the sidelines and resulted in his retirement after 96 league appearances for the Tigers.

His best seasons were in 2015 and 2016 when he finished fourth in the E. B. Cook Medal in 2015 when he had more disposals (540) than any other of his teammates. He finished third behind Jye Bolton and Mitch Andrews in the Cook Medal count in 2016.

The 30-year-old Lee was recruited at the age of 17 at pick No. 60 by the Adelaide Crows in the 2008 AFL draft after having played only a couple of matches for the Claremont colts in 2008. He was still in his football infancy and was delisted after one year with the club.

He returned to Claremont, and after his outstanding 2012 season he was drafted by St Kilda and spent four seasons with the Saints before returning to Claremont for the 2017 season.

He was beset by injuries and managed just 17 AFL matches for St Kilda (ten in 2013, three in 2014, none in 2015 when he was laid low by a serious ankle injury, and four in 2016). During that period when he also performed strongly at centre-half-back, he played in 42 VFL matches for Sandringham. In his time in Melbourne Lee also underwent reconstructions to each shoulder and had an operation to repair a fractured bone in his right hand.

Back at Claremont Lee was the club's leading goalkicker in 2018 (41 goals) and 2019 (33) and he was forced to quit football late last February when he was struck down by an attack of Ross River virus, a debilitating sickness which sapped his energy.

In his 91 league appearances for the Tigers Lee booted 169 goals as well as scoring 15 goals in six Foxtel Cup matches. He consistently delighted the fans with his marvellous high-marking, and in his 97 senior matches for the Tigers he took 452 marks at an average of 4.96 a match.

Few players in recent years have matched Mitchell's strong work ethic, his professionalism and fierce determination.

He showed early promise and when playing for Marist he was the winner of the fairest-and-best award in the 14's grade in the Claremont district junior competition in 2004 and he made his debut in the Tigers colts side as a 16-year-old in 2006 when he finished eighth in the fairest-and-best count and was fifth the following year.

He finished third behind Luke Blackwell and Beau Maister in the club's league fairest-and-best award in 2011, and after kicking three goals in Claremont's grand final victory over East Fremantle in 2012 and winning the Sandover Medal, Mitchell was drafted as a rookie by Port Adelaide, and he made his AFL debut in the round one match against Melbourne in 2013.

After playing 35 AFL matches in four seasons, including only four in 2016 when he won the fairest-and-best award with the Port Adelaide Magpies in the SANFL competition and finished equal third in the Magarey Medal, he was delisted, and he took a year off to travel the world before returning to Tigerland for the 2018 season when he was appointed co-vice-captain with Ryam Lim. He was co-captain with Ian Richardson in 2019 and captain the following year.

Mitchell, an aggressive footballer who frequently played on the edge, has always been an inspirational leader, and it was a tribute to his resilience and longevity that he finished third behind Subiaco's Lachlan Delahunty and Kyal Horsley in the 2019 Sandover Medal and won the E. B. Cook Medal for the second time. He also finished second in the Cook Medal in 2010, third in 2011 and third again, in 2018.

He represented WA in four interstate matches and ended his career with a total of 170 Sandover Medal votes. An indication of his commitment and ferocity on the field is that he laid 676 tackles in his 141 WAFL league appearances and six Foxtel Cup contests.

The 29-year-old Hamp bows out after a wonderful career of 157 WAFL league matches and six Foxtel Cup appearances as one of Claremont's most versatile players in recent times, starring both as a key forward and key defender.

A selfless footballer who was named in the WAFL Team of the Year in 2018 and 2019 as a key defender, Hamp played in Claremont's reserves premiership sides in 2011 and 2012 before developing into one of the club's most dependable and influential senior players.

Having the ability to read the play astutely, Hamp was a splendid on-field leader and organiser, apart from possessing excellent marking and kicking skills. Few players in the WAFL competition in the past decade have been able to match Hamp's great ability to shut down a dangerous forward. His fellow-backmen have relied heavily on his guidance and encouragement.

Serious damage to his right ankle forced him to miss four matches at the end of the 2019 season, and a fractured right hand restricted him to ten appearances this year.

With 2021 bringing so much uncertainty to the community football landscape, I think it is certainly fair to say that seeing our great game return to somewhat of its original format following on from COVID, brought plenty of joy to the people of the Claremont District. Our highly committed club presidents and their fabulous committees remained agile whilst operating in at times, unexpected circumstances navigating COVID to get the season underway. These clubs are made up of dedicated volunteers, eager to give back to football in some capacity in which they do a fantastic job. The WAFC truly value the contribution of all volunteers across junior football within the Claremont District.

Community participation reached new heights in 2021 with all forms of football continuing to go from strength to strength in the Claremont District. Across 12 clubs, Auskick surged with a 16% growth in male participants, and a 35% growth in female participation. Junior football across the modified and youth competitions also increased with a 6% increase in mods and an 11% increase in youth.

THE RP RODRIGUEZ SHIELD

The RP Rodriguez Shield honors a distinguished West Australian football administrator and respected contributor to WA Football, Pat Rodriguez. The Rodriguez Shield was introduced in 1957 and is presented to the most consistent team over the three grades of football. Rodriguez began his administrative career with Claremont, and later served terms as senior Vice President and President of the WANFL, and as President of the ANFC. A league team receives 10 points for a win, the reserves 4 points and the colts 4 points. It has been won by the following clubs:

The fundraising activities and sponsorship of the Club continues to be important in providing much needed cash for the Club to effectively achieve its objectives.


Significant Changes

No significant change in the nature of these activities occurred during the year.



Note 1. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

Claremont Football Club Inc. has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period and effective for an accounting period that begins on or after 1 July 2020. Any new revised or amended accounting standards or interpretations that are not set mandatory have not been early adopted.

The adoption of these Accounting Standards and Interpretations did not have any significant impact to the financial performance or position of the Association.

Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board ('AASB'), the Associations Incorporation Act 2015 (WA) and associated regulations, as appropriate for not-for-profit oriented entities.

Historical cost convention

The financial statements have been prepared under the historical cost convention.

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying Claremont Football Club Inc.'s accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 2.

Revenue recognition

Revenue is recognised at an amount that reflects the consideration to which the association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the association: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration with the transaction price, if any, reflects concessions provided to the customers such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of the variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

Sales revenue

Events, fundraising and raffles are recognised when received or receivable.

Donations

Donations are recognised at the time the pledge is made.

Grants

Grants are recognised at their fair value where there is a reasonable assurance that the grant will be received and all attached conditions will be complied with.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial assets.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

Borrowing Costs

Borrowing costs are recognised as an expense when incurred.

Leases

The determination of whether an arrangement is or contains a lease is based on the substance of the arrangement and requires an assessment of whether the fulfilment of the arrangement is dependent on the use of a specific asset or assets and the arrangement conveys a right to use the asset.

(i) Club as a lessee

Finance leases, which transfer to the club substantially all the risks and benefits incidental to ownership of the leased item, are recognised at the inception of the lease at the fair value of the leased property or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are recognised as an expense in profit or loss. Capitalised leased assets are depreciated over the shorter of the estimated useful life of the asset and the lease term if there is no reasonable certainty that the Club will obtain ownership by the end of the lease term.

Leases (continued)

Operating lease payments associated with short-term leases and leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short term leases are leases with a lease term of 12 months or less. Low-value assets comprise of office equipment.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in Claremont Football Club Inc.'s normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the Claremont Football Club Inc.'s normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Trade and other receivables

Other receivables are recognised at amortised cost, less any provision for impairment.

Inventories

Inventories are measured at the lower of cost and net realisable value. Inventories are accounted for at purchase cost on a first in first out basis.

Investments and other financial assets

Investments and Financial assets in the scope of AASB 139 *Financial Instruments: Recognition and Measurement* are classified as either financial assets at fair value through profit or loss, available for sale investments or loans and receivables. When financial assets are recognised initially, they are measured at fair value. The Club determines the classification of its financial assets at initial recognition.

(i) Classification of financial instruments

The Association classifies its financial assets into the following measurement categories:

- those to be measured at fair value (either through other comprehensive income, or through profit or loss); and
- those to be measured at amortised cost.

The classification depends on the Association's business model for managing financial assets and the contractual terms of the financial assets' cash flows.

The Association classifies its financial liabilities at amortised cost unless it has designated liabilities at fair value through profit or loss or is required to measure liabilities at fair value through profit or loss such as derivative liabilities.

(ii) Financial assets measured at amortised cost

Debt instruments

Investments in debt instruments are measured at amortised cost where they have:

- contractual terms that give rise to cash flows on specified dates, that represent solely payments of principal and interest on the principal amount outstanding; and
- are held within a business model whose objective is achieved by holding to collect contractual cash flows.

Investments and other financial assets (continued)

These debt instruments are initially recognised at fair value plus directly attributable transactions costs and subsequently measured at amortised cost. The measurement of credit impairment is based on the three-stage expected credit loss model described below in note (c) Impairment of financial assets.

(a) Financial assets measured at fair value through other comprehensive income

Equity instruments

Investment in equity instruments that are neither held for trading nor contingent consideration recognised by the Association in a business combination to which AASB 3 "Business Combination" applies, are measured at fair value through other comprehensive income, where an irrevocable election has been made by management.

Amounts presented in other comprehensive income are not subsequently transferred to profit or loss. Dividends on such investments are recognised in profit or loss unless the dividend clearly represents a recovery of part of the cost of the investment.

(b) Items at fair value through profit or loss

Items at fair value through profit or loss comprise:

- * items held for trading;
- * items specifically designated as fair value through profit or loss on initial recognition; and
- * debt instruments with contractual terms that do not represent solely payments of principal and interest.

Financial instruments held at fair value through profit or loss are initially recognised at fair value, with transaction costs recognised in the income statement as incurred. Subsequently, they are measured at fair value and any gains or losses are recognised in the income statement as they arise.

Where a financial asset is measured at fair value, a credit valuation adjustment is included to reflect the credit worthiness of the counterparty, representing the movement in fair value attributable to changes in credit risk.

Financial instruments held for trading

A financial instrument is classified as held for trading if it is acquired or incurred principally for the purpose of selling or repurchasing in the near term, or forms part of a portfolio of financial instruments that are managed together and for which there is evidence of short-term profit making, or it is a derivative not in a qualifying hedge relationship.

Financial instruments designated as measured at fair value through profit or loss

Upon initial recognition, financial instruments may be designated as measured at fair value through profit or loss. A financial asset may only be designated at fair value through profit and loss if doing so eliminates or significantly reduces measurement or recognition inconsistencies (i.e. eliminates an accounting mismatch) that would otherwise arise from measuring financial assets or liabilities on a different basis.

A financial liability may be designated at fair value through profit or loss if it eliminates or significantly reduces an accounting mismatch or:

- * if a host contract contains one or more embedded derivatives; or
- if financial assets and liabilities are both managed and their performance evaluated on a fair value basis in accordance with a documented risk management or investment strategy.

Where a financial liability is designated at fair value through profit or loss, the movement in fair value attributable to changes in the Association's own credit quality is calculated by determining the changes in credit spreads above the observable market interest rates and is presented separately in other comprehensive income.

(c) Impairment of financial assets

The Association applies a three-stage approach to measuring expected credit losses (ECLs) for the following categories of financial assets that are not measured at fair value through profit or loss:

- * debt instruments measured at amortised cost and fair value through other comprehensive income;
- * loan commitments; and
- * financial guarantee contracts.

Investments and other financial assets (continued)

No ECL is recognised on equity investments.

Determining the stage for impairment

At each reporting date, the Association assesses whether there has been a significant increase in credit risk for exposures since initial recognition by comparing the risk of default occurring over the remaining expected life from the reporting date and the date of initial recognition. The Association considers reasonable and supportable information that is relevant and available without undue cost or effort for this purpose. This includes quantitative and qualitative information and also, forward- looking analysis.

An exposure will migrate through the ECL stages as asset quality deteriorates. If, in a subsequent period, asset quality improves and also reverses any previously assessed significant increase in credit risk since origination, then the provision for doubtful debts reverts from lifetime ECL to 12-months ECL. Exposures that have not deteriorated significantly since origination are considered to have a low credit risk. The provision for doubtful debts for these financial assets is based on a 12-months ECL. When an asset is uncollectible, it is written off against the related provision. Such assets are written off after all the necessary procedures have been completed and the amount of the loss has been determined. Subsequent recoveries of amounts previously written off reduce the amount of the expense in the income statement.

The Association assesses whether the credit risk on an exposure has increased significantly on an individual or collective basis. For the purposes of a collective evaluation of impairment, financial instruments are grouped on the basis of shared credit risk characteristics, taking into account instrument type, credit risk ratings, date of initial recognition, remaining term to maturity, industry, geographical location of the borrower and other relevant factors.

(d) Recognition and derecognition of financial instruments

A financial asset or financial liability is recognised in the balance sheet when the Association becomes a party to the contractual provisions of the instrument, which is generally on trade date. Loans and receivables are recognised when cash is advanced (or settled) to the borrowers.

Financial assets at fair value through profit or loss are recognised initially at fair value. All other financial assets are recognised initially at fair value plus directly attributable transaction costs.

The Association derecognises a financial asset when the contractual cash flows from the asset expire or it transfers its rights to receive contractual cash flows from the financial asset in a transaction in which substantially all the risks and rewards of ownership are transferred. Any interest in transferred financial assets that is created or retained by the Association is recognised as a separate asset or liability.

A financial liability is derecognised from the balance sheet when the Association has discharged its obligation or the contract is cancelled or expires.

(e) Offsetting

Financial assets and liabilities are offset and the net amount is presented in the balance sheet when the Association has a legal right to offset the amounts and intends to settle on a net basis or to realise the asset and settle the liability simultaneously.

Property, plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the Claremont Football Club Inc. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Interest-bearing loans and borrowings

All loans and borrowings are initially recognised at the fair value of the consideration received less and directly attributable transaction costs.

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the effective interest method.

Gains and losses are recognised in profit or loss when the liabilities are derecognised.

Trade and other payables

These amounts represent liabilities for goods and services provided to the Claremont Football Club Inc. prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Employee benefits

Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

Other long-term employee benefits

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are measured at the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

Defined contribution superannuation expense

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current year.

Going Concern

The financial statements have been prepared on a going concern basis which contemplates the continuity of normal business activities and the realisation of assets and the settlement of liabilities in the ordinary course of business.

For the year ended 31 October 2021, the Club incurred a net surplus of \$161,225 (2020: \$498,504) and had cash inflows from operating activities of \$341,571 (2020: \$410,189).

The Club has overdraft facilities of \$450,000 which was undrawn at the balance date. The Club also has a five year secured loan with Westpac which matures on 21 September 2022. As at balance date there is no principal amount outstanding on this loan, with the Club having made repayments of \$131,516 in excess of minimum repayments.

The Board has prepared a budget, which indicates that the Club will have sufficient cash flows to meet all commitments and working capital requirements for the 12 month period from the date of signing this financial report. On this basis the Board is satisfied that the going concern basis of preparation is appropriate.

Note 2. Critical accounting judgments, estimates and assumptions

The preparation of the financial statements requires management to make judgments, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgments and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgments, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgments and estimates will seldom equal the related actual results. The judgments, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Estimation of useful lives of assets

Claremont Football Club Inc. determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Impairment of non-financial assets other than goodwill and other indefinite life intangible assets

Claremont Football Club Inc. assesses impairment of non-financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to Claremont Football Club Inc. and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value-in-use calculations, which incorporate a number of key estimates and assumptions.

Employee benefits provision

As discussed in note 1, the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

Redevelopment Activities

In 2017 the Club has completed redevelopment activities at Claremont Oval pursuant to an agreement with LandCorp whereby the parties have agreed to the cancellation of the Club's lease, and granted freehold title of the Clubhouse land to the Club on a conditional use basis. Redevelopment Activities were funded by Landcorp, up to an amount of \$16.5m, and have not been reflected in this financial report.

As part of the redevelopment, and pursuant to an agreement between the Club, the Town of Claremont and the purchaser of the land immediately to the north of the Club's facilities, the Club was entitled to 81 car bays. During the year, the construction of the 81 car bays in the basement of the building to the north of the Club's facilities was completed. The Club made a contribution (funded by Landcorp) of \$1m to the cost of their construction. The value of these car bays has not been reflected in this financial report.

Maintenance Fund

During 2018, the excess land to the North of the Club facilities was sold by the Government and \$1.5m of the proceeds was granted to the Club pursuant to the terms of a Trust Deed.

Under the terms of the Trust Deed, the Club is required to keep these proceeds, and any interest earned, in an auditable Trust Account. The funds held in the Trust Account (separate to the financial statements) may only be applied to the costs of repairing, maintaining, and renewing the Club's premises in accordance with an Asset Management Plan that has been approved by the Government.

During the year, \$138,401 was expended on such repairs and maintenance. Of this amount, \$7,651 was sourced from the Trust Account, with the balance being funded by operating cashflows. At year end, the closing balance of the Trust Account was \$1,500,000.





INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF CLAREMONT FOOTBALL CLUB INC.

Qualified Opinion

We have audited the accompanying financial report, of Claremont Football Club Inc. ("the Club"), which comprises the statement of financial position as at 31 October 2021, statement of changes in equity, the statement of profit or loss and other comprehensive income and the statement of cash flows for the year ended on that date, notes comprising a summary of significant accounting policies and other explanatory information, and the directors' declaration.

In our opinion, except for the matters described in the Basis for Qualified Opinion section of our report, the financial report of Claremont Football Club Inc. is in accordance with the club constitution, including:

- (i) giving a true and fair view of the company's financial position as at 31 October 2021 and of its performance for the year ended on that date; and
- (ii) complying with Australian Accounting Standards – Reduced Disclosure Requirements, the Associations Incorporation Act 2015 (WA) and associated regulations.

Basis for Qualified Opinion

Revenue Recognition

As is common for organisations of this type, it is not practicable for the Club to maintain an effective system of internal control over cash receipts and payments until their initial entry in the accounting records. Our audit relating to these items was therefore limited to the amounts recorded in the accounts.

Redevelopment Activities

We draw attention to Note 7 in the financial report with respect to the Club's redevelopment activities completed in 2017. The funds received and spent on these activities have not been accounted for in this financial report, as such our audit procedures have been limited to that presented in the financial report. As a result, we have not obtained appropriate audit evidence to provide a basis for an audit opinion on the redevelopment activities and the effect of these has not been determined on the financial performance, position and cash flows of the Club.

We conducted our audit in accordance with Australian Auditing Standards. Those standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance about whether the financial report is free from material misstatement. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the Club in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's *APES 110 Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Other Information

The directors are responsible for the other information. The other information comprises the information included in the Club's annual report for the year ended 31 October 2021, but does not include the financial report and our auditor's report thereon.

Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial report, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Directors' Responsibility for the Financial Report

The directors of the Club are responsible for the preparation of the financial report that gives a true and fair view and have determined that the basis of preparation described in Note 1 to the financial report is appropriate to meet the requirements of the Club's constitution and Associations Incorporation Act (WA) 2015 and is appropriate to meet the needs of the members. The directors' responsibility also includes such internal control as the directors determine is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the directors are responsible for assessing the ability of the Club to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Club or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Report

Our responsibility is to express an opinion on the financial report based on our audit. - Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Club to express an opinion on the financial report. We are responsible for the direction, supervision and performance of the Club audit. We remain solely responsible for our audit opinion.

We communicate with the directors regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the directors with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.
