<b>Summary:</b> 2020 Coach form is now available for completion	<b>Action:</b> All clubs must submit details of coaches on the attached form by 24 February 2020. This is a compulsory return. A \$100 fine will apply if not returned by the due date.

Details for coaches must be completed for each team nominated on the form attached to this email and returned no later than 24 February 2020. This information is also required for all assistant coaches whether paid or unpaid. If you have not appointed all coaches by the due date, please return with as much information as possible.

## REMUNERATION

Coaching payments for any one team may not exceed \$15,000. Only the senior coach of each team in a club is permitted to be remunerated for his or her knowledge and service as a coach and play without forfeiting his or her amateur status.

## ACCREDITATION AND REGISTRATION

It is mandatory that all Perth Football League coaches hold a valid Senior accreditation prior to coaching their first game.

Coaches must register annually with CoachAFL. If coaches have not registered with CoachAFL, you will not be able to select them on the team sheet. Please refer to Circular 09, 2019-20 for further information on accreditation and registration of coaches.

## INDUCTION

Please ensure you coaches are aware of the compulsory coach inductions to be held for each grade as listed below. This year an induction will be held for each (league) grade. For example if you're league side is in B Grade, all coaches from your club attend the session on 25 February (League, Reserves, D, D Reseves, Drew Banfield Colts and Brett Jones Colts).

All sessions will be held at 6.15pm in the McGrath Pavillion at Ernest Johnson Oval, South Perth.

A, A Reserves, Colts, Thirds, Fourths, etc	Thursday 27 February 2020
B, B Reserves, Colts, Thirds, Fourths	Tuesday 25 February 2020
C1, C1 Reserves, Colts, Thirds	Monday 24 February 2020
C2, Reserves, Colts, Thirds	Monday 10 February 2020
C3 Reserves, Colts, Thirds	Thursday 13 February 2020
C4, Single Team, Colts	Thursday 20 February 2020
Women's	Wednesday 18 March 2020

Where the senior/head coach is unable to attend, the team's designated assistant coach(s) must attend. In other words, 1 team/1 coach required to attend.
