PRESIDENTS REPORT

Swansmen Report

The Swansmen enjoyed a very busy and **VERY** successful 2024 and once again provided many opportunities for our members to enjoy good fellowship and help raise some very valuable money for the Club at the same time.

The year commenced as normal with the Annual Planning Seminar in February followed by the Lounge Busy Bee. The first of the Swansmen monthly dinners kicked off in March as did the fundraising for 2024.

The monthly dinner meetings were successful with approximately 30 in attendance each month. We heard from coaches, players and a diverse range of entertaining guest speakers including League Coach Andrew Pruyn, Geoffery Thomas (Aviation expert), Mike McKenna (CEO Optus Stadium), cricket legend Dennis Lillee, past players Bob Beecroft and Max George and our own Marc Hocking (Cyber Security) and Ross Fitzgerald (a good horse story).

The Auction was sponsored by Retravision again this year, donating \$6,000 of electrical items, which, along with the 90th Anniversary player jumpers, \$11,625, helped in raising the huge amount of \$71,850. Thanks to the many Swansmen members and associates for cash and product donations.

We have had another exceptionally successful fundraising year. Over **\$116,000** net was raised through:

- the Thursday Members Night, Chase the Ace, raffle and wheel \$14,700.
- AFL Grand Final/Cash Bonanza Raffle \$12,400 (thanks to Peter Snow for coordinating).
- Auction \$72,000 (thanks to the Committee, Ross Leipold and the Club staff and all the donors).
- Wine Wall \$7,000 (thanks to Des Hardiman, Darryl Crotty and the wine sub-committee)
- Home Game Winning Margins \$4,200 (thanks to George van der Meulen).
- Swansmen Lounge Home Game Bar \$9,900 (thanks to 'bar manager' Peter Bacon).
- Plus, our Membership Subs, Sponsor-A-Picket, monthly dinner meetings and fines.

This amount was returned to the Club through the annual sponsorship of a Count-Me-In table; the Women's League Best Player Awards; the Men's League Leading Goal Kicking Award, contribution to the renovations of the Club facilities and an end of season balance to the Club of \$110,000. This has been earmarked for special projects in 2025.

The support of the Thursday Members' night has been outstanding on all fronts. To the members who support us every week, the ticket sellers Tim Outred, Peter Clements, the raffle prize shoppers, Andrew Holmes and Peter Hodyl, the lotto ticket donator Darryl Crotty and all other helpers, we have created something special.

We continue to work with and welcome our Judda Bee members and look forward to strengthening the networking opportunities and mutual benefits that may arise. We ask all members to support and consider all the Club and Auction sponsors when in the market for appropriate goods and services.

I would like to sincerely thank your Committee for their support and strong contribution this year and to all the Club staff for their assistance and catering. I also acknowledge the interaction and cooperation we have with the Board, Staff and the Past Players & Officials Association.

We welcome new members to the Swansmen group. It is a great way to support the Club and get to experience it from the inside. Good luck to everyone – especially the players, for season 2025.

The 15th June 2024 was a significant and special day at Steel Blue Oval as we paid tribute to the great John Todd in a memorial match against South Fremantle following his death just over a week earlier. It was also the day the Swansmen named their lounge – after long standing member Neville Bassett AM.

When it was decided to name the recently renovated Swansmen Lounge, it was very fortunate that Neville was a rare apology for that Committee Meeting, because it was a unanimous vote. Following consultation with a number of Life Members we went about preparing the details for a naming ceremony and sign writing all under code of secrecy.

Neville joined the Swansmen in 1987 and immediately went onto the Committee. And he has been there ever since – 37 years of the 40 years of Swansmen. He has held the posts of Treasurer, Vice President, Secretary and President. Neville was on the Auction Committee between 1987 and 2018 and held the additional role of financial controller during most of that time. Month SWANSMEN DINNER GUEST SPEAKERS

March Andrew Pruyn (SDFC League Coach)

League Coach Andrew outlined his plans for the season hoping to play finals footy and welcoming new recruits – Nic Rokahr and Jye Chalcraft. Despite losing up to 10 players from last year, Andrew is confident the current squad and new young players can take the step to finals.

April Geoffrey Thomas (Aviation journalist and historian)

Geoffery gave an insight into where his passion into aviation came from, which included his love of the DC-8, being the first male Flight Attendant, missing a trip on the Concorde due to his son Nick' 6th Birthday and having been banned from Qantas 3 times.

May Mike McKenna (Optus Stadium CEO)

Ross Fitzgerald (A Never Ending Story)

NOTES TO THE FINANCIAL STATEMENTS

Note 1: Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements under the Associations Incorporation Act 2015 (WA).

The Committee has determined that the Association is not a reporting entity because there are no users dependent on the financial statements. Under the Act, the Association is classified as Tier 1 for reporting purposes and does not require an annual review or audit unless requested and not registered for GST.

Note 2: Current Liability

The Swansmen are committed to pay out the Chase the Ace Jackpot (\$5,756) at some time in the future. The Swansmen have committed to contribute up to \$110,000 in 2025 for Club upgrades and projects.

Note 3. Funds to SDFC - Facility Improvements

The SDFC Donation was \$102,386 from 2023 proceeds. Included new carpet and vinyl to bar, external doors, west stage wall, camera tower, changeroom memorabilia and sundry electrical and other maintenance.
