In order to comply with our obligations under the *Privacy Act 1988* (Cth) (**Privacy Act**), we are required to notify you of certain matters when we collect your personal information (**Notice**). These matters are outlined below.

Why we collect your personal	We collect your personal information in order to provide our services. By registering with the WAF, we will collect your personal information in order to:	
information?	 (a) co-ordinate your participation in organisations and competitions run by the WAF; (b) if applicable, record your participation in community football events and organisations, which may include details of your performance or activities in such events; 	
	(c) provide you with information or updates about WAF, football in Western Australia and our events; and	
	(d) for internal purposes including the administration of our website, data analytics, compliance with law, legal processes or our internal policies and procedures.	
Who will we	In order to provide our services to you and for the purposes specified above, we may need to disclose	
disclose your	your personal information to third parties, which may include:	
personal information to	(a) our affiliates such as the AFL, WAFL, WAFLW or other professional and amateur football clubs; or	
and will this be overseas?	(b) third party service providers who may help us, for example, to operate our competitions, such as PlayHQ and Officials HQ and other services providers. Such third parties are generally located in Australia. WAF ensures that your personal information is not disclosed overseas otherwise than in accordance with the Privacy Act.	
Do we collect	We do not ask for, and do not knowingly collect, sensitive information from you. In some specific	
sensitive	circumstances we may inadvertently collect sensitive information about you, such as your racial or	
information?	ethnic origin or religious affiliation in connection with your registration details or your health	
	information in connection with records relating to your participation in events or competitions	
	operated by us. We will only collect sensitive information from you with your consent.
