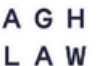

## FOOTBALL OPERATIONS

### KEPLER BRADLEY

Darren Harper did a great job helping our young Reserves group finish on top of the ladder only losing 1 game in the home & away season.

Beating Subiaco by 10 points in the second semi-final saw us make our way into the grand final where we eventually played East Fremantle. The game was played with a high tempo but unfortunately East Fremantle worked harder with and without the ball to see them 7 goals up at 3 quarter time. We fought back in the last quarter kicking the first 3 goals, but we ran out of time to eventually go down by 29 points. Kai Dehavilland was our best with his hardness at the ball a feature.

We have a really exciting future with a number of young players developing their games and knocking on the door of league selection. Menno Inverarity had an outstanding year with his running a real feature, Max Rohr showed how flexible he is playing a variety of roles and making the WA state 18's squad, Sam Van Rooyen provided a target up forward and Bailey Banfield, Kai Dehavilland and Mitch Barron continue to develop as inside midfielders.

For the 7th year in a row our League side made the finals after winning 11 home & away games to finish 5th on the ladder. We started the season very slow losing our first 5 out of 6

games leaving us on the bottom of the ladder after round 7. The turnaround for the remainder of the season was simply incredible, we won 10 of our next 12 games to make finals yet again, something which our club should be very proud of. Injuries to key players throughout the year really tested our depth and provided opportunities to players and they didn't let the club down.

We turned our attention to East Fremantle in the first final at Revo Fitness Stadium. The first quarter saw East Freo lock it in their front half and have multiple shots on goal. Inaccuracy kept us in the game and in the second quarter we were able to get momentum and capitalise opening up an 18 point lead at half time. The second half was a very even contest with both teams throwing everything they had but we were able to stretch the lead to 24 points when the final siren went. Hamish Davis was outstanding with 4 goals and showing recruiters his running capacity, while Rogers, England and Eastland dominated the midfield.

We then headed to Rushton Park to play Peel Thunder. Full of confidence we matched a Peel side littered with AFL players. We opened up a 17 point lead in the last quarter only to see it slowly get eaten into by an experienced Peel side. It was a heartbreaking loss with Peel winning the game with only seconds remaining. The result will certainly motivate players and coaches in the preseason. Bailey Rogers was voted Claremont's best player while Zac Mainwaring's pressure was a real highlight all day.





A lot of positives came out of the year with a number of young players making the most of league opportunities. Jack Musika became a potent small forward, Hamish Davis showed the football world what he's capable of, Joshua Howard and Jasper Peace have big futures in defence, Sam Alvarez and Ben Elliott became a top line winger and inside midfielder. Zac Mainwaring built on his 2023 season with another great year while our midfield was arguably the best in the comp after round 7 led by Bailey Rogers, Callan England, Jye Bolton and Oliver Eastland.

- Callan England won the Sandover medal and Menno Inverarity won the Prendergast medal

- Top 3 in this year's League B&F was Bailey Rogers, Callan England and Oliver Eastland
- Top 3 in this year's Reserves B&F was Menno Inverarity, Ashton Bryant and Kai Dehavilland
- We had 2 state representatives - Oliver Eastland & Bailey Rogers
- Milestones achieved: Bailey Rogers - 150 games, Oliver Eastland - 100 games, Lachie Martinis - 100 games, Oliver Sheldrick - 50 games, and Ben Elliott - 50 games

## TALENT MANAGER REPORT

Another successful season is in the books for the Claremont talent programs with plenty to reflect on as the club continues to prepare its young brigade for their futures at Tigerland.

#### WAFL COLTS

2024 was an amazing season for our Colts, and not just because of the club's 18th Premiership in the grade. Exposing 64 young men to the level within a 16-game season (plus 2 finals) is also amazing. It's the highest number of players I can find recorded data of the club calling upon in a single Colts season, and indeed this dual pursuit of maximising opportunities while achieving on-field success is something the program continues to do well.

This season saw parallels to last as we again only suffered two losses and won the 2nd Semi Final to progress straight through to the Grand Final. However, unlike in 2023, this year we had the "challenge" of finishing on top of the ladder, which, with the way the finals structure works, does mean a lack of football being played at the back end of the season. This was definitely a concern for

a team that had endured so much weekly turnover throughout the year – not only through the usual unavailability of PSA players, but also by virtue of having an unprecedented number of boys away on State 18s duty. Ultimately though, the rock-solid connection of the playing group (another parallel with 2023's premiership winners) ensured this lack of continuity was not a barrier to our success.

While this year, more than ever, was a "squad effort", I do want to acknowledge the Top 3 in our Fairest & Best – Austin van der Struyf, Aiden Riddle and Hugh Boxshall – for their outstanding seasons. Austin (Interchange) was also named in the WAFL Colts Team of the Year alongside Clancy Dennis (Back Pocket), Jett Sibosado (Half Back Flank), Hamish Davis (Half Forward Flank) and Lucas Ravenhill (Full Forward). All other individual accolades are listed later in this publication, but just finally, I want to wish our AFL Draft hopefuls all the very best. At the time of writing, a number of boys have recently performed strongly at the AFL National & State Draft Combines, and hopefully some of them will achieve their dreams later in the year by finding their way onto an AFL list.

Ricki Smith has proven a fantastic appointment as Colts Coach – it's never easy taking over a program that won a premiership the year prior, but Ricki quickly put his own spin on things and did a brilliant job throughout the season. Ably supporting Ricki were Ritchie Hore, Adam Spencer, Andie Fagan, Sam Bevan, Jack Bradshaw and Owen Thomas – thanks gents for your dedication throughout the season. We also owe a lot to our support staff, namely Team Manager Bern Willett (this was Bern's sixth Colts premiership as Team Manager); Property Managers Jack Denton and Trevor

Naulls; S&C Coach Mika Berman; Physiotherapist Ben Rushforth; Dr Lionel Lim; Head Trainer Beth Ewens and the entire club trainer group; Wellbeing Staff Shane Yardley, Dr Steve Allsop and Ryan Clune; and Nutritionist Jacob Shaw.



## FUTURES & DEVELOPMENT SQUADS

Our Futures squad performed strongly in their carnival early in the year, emphasised by the fact that five boys managed to progress up and make their Colts debuts in the months that followed – the most we have had do this in a single season for a long time. Congratulations to our 2024 Futures award winners: Tiger Award – Harper Banfield, Most Consistent Award – George Gale, Developing Talent Award – Heath Mellody, Emerging Talent Award – Damien Newry and MVP Award – Tom Brown. George, Damien and Tom also earned selection in the WA State 16s squad alongside Futures teammates Elijah Dennis and Benji van Rooyen – well done boys. Thank you to outgoing Futures Coach Ben Willett for three years of wonderful service in the role and his Assistant Coaches Alec Waterman, Brett Wenn and Andie Fagan and Head S&C Coach Ben Thomasian.

Thanks also to our Development Squad Coaches Jack Schwarze, Brett Wenn, Andie Fagan, Chris Tan, Cody Angove, Leon Wilson, Chris Bandy and S&C Coaches Bessie Milios and Tegan Headley. These

people, together with Lachie Davis who was a valuable addition in administering the programs this year, oversaw a strong block of learning and growth for both our 14s & 15s groups, with their journeys at the club only just beginning.

## REGIONAL DEVELOPMENT

2024 was another strong year for our regional academies, with both the Great Southern Storm and the Kimberley Spirit again fielding teams in the CBH Country Colts Championships, while five Spirit players slotted into the Storm team that represented Claremont in the WAFC Regional 15s Carnival. After a hiatus due to COVID and last year's floods, it was great to have the Kimberley Colts Championships back up and running this year for what was a big day of activities both on and off the footy field in Kununurra – thanks to Garnduwa for their efforts in bringing the carnival back to life. Our annual Colts fixture in Albany was another huge success – in fact the massive win had the boys asking if we could play down there every week! A big thank you to the Albany Sharks Football Club who, as always, were amazing hosts.

## SENIOR COACH'S REPORT

### ASHLEY PRESCOTT

2024 was really the season of two halves, at the end of Round 8 we were 2 wins and 5 losses and on the bottom of the WAFL ladder. It is how clubs and individuals behave in challenging times that matters, and the way the playing group, coaches and support staff stuck together, collectively took responsibility, realigned our key priorities, narrowed our focus, and raised our accountability was a credit to everyone involved.

Through this shift in mindset and effort from Round 9 onwards we gained the respect of our members, supporters and the broader football community for the brand of football we played. Our defensive intensity suffocated the opposition, tackling numbers increased, trust grew through being more team orientated, and the harder we worked for each other and attacked the opposition, the more fun we had. Ultimately, we fell short, but we became a more connected and united team.

I understand how people can think about the 'what if's' if our season continued, but I do not live in, or entertain these thoughts for one second, we won 12 games, lost 8, and finished 5th after the home and away seasons. You cannot win a premiership in March and April but you can lose one, so we learn our lessons, solidify our blueprint, and get to work.

## ROGERS IS AN INSPIRATION

"Bailey Rogers has turned into a genuine leader on and off the field and he inspires his teammates not only with his deeds, but with his character and the way he embraces any role."

That was Claremont league coach Ash Prescott's observation after Rogers was awarded the E. B. Cook Medal as the club's fairest-and-best player in 2024.

The 27-year-old Rogers, a driving force in the midfield throughout the season, received 262 votes to win the award from Callan England (255), Ollie Eastland (229) and Jye Bolton (82). This was his second Cook Medal, following his success in 2021 when he also won the Sandover Medal.

Rogers began at Claremont as a 16-year-old and he lined up in a back pocket in the colts side which won the premiership that year, beating South Fremantle by a goal in the grand final. The colts side lost to Swan Districts in the 2014 grand final before Rogers was captain of the side which beat Swans by 70 points in the 2015 colts grand final.



Rogers, who was a prominent performer for Western Australia in the 16s and 18s national carnivals, enjoyed a splendid apprenticeship, playing 33 matches for the colts in three seasons before making his league debut in the round 21 match against East Fremantle at the Showgrounds in 2015.

He excelled as a fearless, uncompromising lockdown defender for several seasons before making the switch into the midfield in 2021, a role which saw him quickly develop into a champion.

"My view on Bailey is that he is without doubt in my time in football the best player I have seen not to go on to the next level (AFL)," said Prescott. "He is an out and out superstar. What I reckon he added to his game this year was he became a genuine midfielder."

"I worked closely with him, along with the midfield coaches. He has come a long way, just the way he moves around the ground, his balance, his offence and defence. He has grown enormously as a footballer, and he has a lot more improvement left in him. He is a goalkicker and you can also put him back behind the ball where he adds stability. There's nowhere he can't play."





Rogers, who has played for WA in interstate matches in 2019, 2021, 2022 and 2024, became a life member of Claremont in July this year when he notched his 150th league appearance in the match against East Perth at Revo Fitness Stadium. This was a pinnacle of a distinguished football journey which has seen him dogged by a series of debilitating injuries, and it is a measure of the man who has steadfastly refused to utter a complaining word.

He simply gets on with the job with a minimum of fuss despite his injury misfortunes, which include multiple fractures in his left femur and knee, suffering from sesamoiditis, a painful affliction of the foot, and Achilles problems in both legs.

Rogers has been a shining light with Claremont for more than a decade, during which he has played 156 league matches and scored 84 goals.

Apart from his two E. B. Cook Medals, he has finished third in the award behind Kane Mitchell and Declan Mountford in 2019, and second to Jye Bolton in 2022.

Rogers describes his time at Claremont as "a great place to be," and he would dearly love to be part of a Tigers premiership side following the disappointment of losing grand finals to South Fremantle by three points in 2020 and by two goals by West Perth two years later.

## ENGLAND JOINS EXCLUSIVE CLUB

Smooth-moving midfielder Callan England was rewarded for an outstanding season in 2024 when he was awarded the Sandover Medal in September, a richly deserved honour which enabled him to join an exclusive club as the 14th Claremont footballer to win the medal as the fairest-and-best player in the WAFL league competition.

This accolade came after England had experienced the highs and lows in a roller coaster career which included being a member of Hale School's winning Alcock Cup team in 2015 and 2017, shining with the State 16s and 18s teams and playing in three colts grand finals for Claremont and being in the winning side in 2015 and 2017.

He was selected in October 2017 by the West Coast Eagles in the AFL rookie draft before the major disappointment of being delisted at the end of the following year without having the opportunity to play in an AFL fixture. He lost his passion for the game when he returned to Claremont and played in only eight of Claremont's 21 league matches in 2019.

However, England produced an outstanding individual performance in the reserves grand final in a three-point loss to West Perth, taking six marks and having 28 disposals, including seven inside 50s.

He had well and truly tuned the corner and bounced back in 2020 when he thoroughly enjoyed playing with his mates, and he appeared in all of the league side's ten matches in a reduced season due to the coronavirus pandemic. The season ended with a heart-breaking three-point loss to South Fremantle at Fremantle Oval. He finished fifth in the voting for the fairest-and-best award and was named in the WAFL Team of the Year as a half-forward flanker.

Then in the following four years England missed only two matches, one due to Covid and the other when he had a fractured bone in a hand. He made his interstate debut when he played as a half-forward flanker for WA against South Australia at Adelaide Oval in 2021.



Two highlights stood out in 2024 --- when he appeared in his 100th WAFL league match against East Perth in July and when he was the joint winner of the Sandover Medal with Swan Districts' midfielder Nik Rokahr.

A splendid all-round record as an athlete helped England to develop into a quality footballer. Between the ages of 11 and 15, he won several gold medals as a long jumper and in sprints over 100, 200 and 400 metres in State athletic championships.

He does not conform to typical modern-day midfielders, many of whom are muscular and menacing. He is cool, calm, composed, calculating and canny, and he glides around the field as graceful as a cheetah in full flight. He declares he is not a big-and-bash midfielder, preferring to use his pace and agility to advantage.



England is primarily an outside midfielder, whose ability to get into the open and then make use of his precise disposal constantly sets up successful attacking moves. But he also gets involved in plenty of tough midfield tussles, and his tally of 87 tackles this year saw him finish in fourth spot in that category at Claremont, behind Ollie Eastland (112), Zac Mainwaring (97) and Bailey Rogers (93).

"Callan has had a great year," said coach Ash Prescott. "He is a legitimate two-way midfielder and what he does with the ball is wonderful. What he does without the ball is equally as good. His defensive running, his patterns to close down opposition exits, the way he defends and forces turnovers and the way he works at stoppages is outstanding."

## REWARDS FOR CLAREMONT'S WOMEN

"It's incredible and a major breakthrough," declared Jack Schwarze, when explaining the news that the members of Claremont's WAFL women's side will receive match payments for the first time ever, in 2025.

Schwarze, coach of Claremont's WAFLW side, is rejoicing at the WAFL's decision to begin paying players from all clubs, starting with instituting a salary cap of a base \$20,000 for the Tigers, while some other clubs will receive a little more for competitive balance.

Claremont's salary cap will increase to \$25,000 in 2026 and \$30,000 the following year.

Schwarze is currently drawing up contracts for his players. Only players 19 years and over and those turning 19 next year will be eligible to be contracted. All eligible players must receive a payment, with a maximum of \$250, for every match in which they play in the WAFLW league competition.

Claremont will have a tier system with scope to adjust some contracts.

Schwarze, who has led the Tigers to the premiership in two of the last three seasons, explained that Claremont would receive



\$7500 from the WAFL, meaning that the club would have to find sponsors to make up the balance of the \$20,000 salary cap.

"If the funds were there, I would say that our players deserve more," he said. "Players will be paid purely on appearances in the league side".

"I'm sure that the decision to pay our players will help them with their passion and the feeling of respect. Our players have an off-season program where they are expected to complete four to six sessions per week.

"Once the pre-season starts, they will attend three training sessions a week, as well as three sessions in the gym. The ability to pay senior players is a huge step in recognising their level of commitment."

Rachel Ortlepp, captain of the Claremont league side for the past three seasons, who kicked the winning goal late in the Grand Final against East Fremantle at Joondalup in July this year, said: "It's a pinch yourself moment because I never thought we would be paid to play footy.





"It is more symbolic, and I'm sure match payments will have a financial impact with some of our players who are students."

Jacinta Valentini, who is studying a Bachelor of Education at ECU Joondalup as well as working part-time in retail, said: "It is good that we're finally getting recognition, even though I'm not here for the money. I just like playing the sport, and I'm more than happy that I switched from netball to football several years ago."

Valentini (24) has played 66 WAFLW games since joining the Tigers in 2019. She had an outstanding year in 2024, finishing as runner-up for the fairest-and-best award, representing WA in the match against South Australia and then playing in the premiership side.

One of Claremont's star players is 18-year-old Eva O'Donnell, a slightly-built rangy player who impressed with her pace, endurance and all-round skills as a winger and a half-forward.

"The prospect of being paid is amazing," she said. "It was not a possibility when I started, and it is awesome to get paid to do sport. I like to run away (from my opponents)

with the ball, and I like scoring goals.

"I have been playing football since AusKick when I was seven. And at Rosalie Primary school I didn't know what to do at lunchtime, and the teachers suggested I go out and kick the football. So, they got one of the Year Six boys to teach me, and I got to join their junior football club.

"I have played 21 league games with Claremont over the past two years. I used to play wing before moving forward. In 2023 I fractured my left collarbone in a match at Fremantle Oval. I was tackled and it snapped in half, and this forced me to miss the grand final.



"This year I injured my right ankle in the preliminary final against West Perth and missed another grand final."

Ortlepp (27) was Claremont's fairest-and-best player in 2021 and is currently working at the Melaleuca Women's Prison in Canning Vale. Like her teammates she enjoys the professionalism at Claremont, the excellent facilities, and especially the respect shown to all female players at the club.

## THE RP RODRIGUEZ SHIELD

The fundraising activities and sponsorship of the Club continues to be important in providing much needed cash for the Club to effectively achieve its objectives.


**Significant Changes**

**Note 1. Significant accounting policies**

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

**New or amended Accounting Standards and Interpretations adopted**

Claremont Football Club Inc. has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period and effective for an accounting period that begins on or after 1 November 2023. Any new revised or amended accounting standards or interpretations that are not set mandatory have not been early adopted.

The adoption of these Accounting Standards and Interpretations did not have any significant impact to the financial performance or position of the Association.

**Basis of preparation**

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards - Simplified Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board ('AASB'), the Associations Incorporation Act 2015 (WA) and associated regulations, as appropriate for not-for-profit oriented entities.

*Historical cost convention*

The financial statements have been prepared under the historical cost convention.

*Critical accounting estimates*

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying Claremont Football Club Inc.'s accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 2.

**Revenue recognition**

Revenue is recognised at an amount that reflects the consideration to which the association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the association: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration with the transaction price, if any, reflects concessions provided to the customers such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of the variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

*Sales revenue*

Events, fundraising and raffles are recognised when received or receivable.

*Donations*

Donations are recognised at the time the pledge is made.

*Grants*

Grants are recognised at their fair value where there is a reasonable assurance that the grant will be received and all attached conditions will be complied with.

*Interest*

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial assets.

*Other revenue*

Other revenue is recognised when it is received or when the right to receive payment is established.

**Borrowing Costs**

Borrowing costs are recognised as an expense when incurred.

**Leases**

The determination of whether an arrangement is or contains a lease is based on the substance of the arrangement and requires an assessment of whether the fulfilment of the arrangement is dependent on the use of a specific asset or assets and the arrangement conveys a right to use the asset.

*(i) Club as a lessee*

Finance leases, which transfer to the club substantially all the risks and benefits incidental to ownership of the leased item, are recognised at the inception of the lease at the fair value of the leased property or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are recognised as an expense in profit or loss. Capitalised leased assets are depreciated over the shorter of the estimated useful life of the asset and the lease term if there is no reasonable certainty that the Club will obtain ownership by the end of the lease term.

**Leases (continued)**

Operating lease payments associated with short-term leases and leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short term leases are leases with a lease term of 12 months or less. Low-value assets comprise of office equipment.

**Current and non-current classification**

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in Claremont Football Club Inc.'s normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the Claremont Football Club Inc.'s normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

**Cash and cash equivalents**

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

**Trade and other receivables**

Other receivables are recognised at amortised cost, less any provision for impairment.

**Inventories**

Inventories are measured at the lower of cost and net realisable value. Inventories are accounted for at purchase cost on a first in first out basis.

**Investments and other financial assets**

Investments and Financial assets in the scope of AASB 139 *Financial Instruments: Recognition and Measurement* are classified as either financial assets at fair value through profit or loss, available for sale investments or loans and receivables. When financial assets are recognised initially, they are measured at fair value. The Club determines the classification of its financial assets at initial recognition.

*(i) Classification of financial instruments*

The Association classifies its financial assets into the following measurement categories:

- those to be measured at fair value (either through other comprehensive income, or through profit or loss); and
- those to be measured at amortised cost.

The classification depends on the Association's business model for managing financial assets and the contractual terms of the financial assets' cash flows.

The Association classifies its financial liabilities at amortised cost unless it has designated liabilities at fair value through profit or loss or is required to measure liabilities at fair value through profit or loss such as derivative liabilities.

*(ii) Financial assets measured at amortised cost*

**Debt instruments**

Investments in debt instruments are measured at amortised cost where they have:

- contractual terms that give rise to cash flows on specified dates, that represent solely payments of principal and interest on the principal amount outstanding; and
- are held within a business model whose objective is achieved by holding to collect contractual cash flows.

**Investments and other financial assets (continued)**

These debt instruments are initially recognised at fair value plus directly attributable transactions costs and subsequently measured at amortised cost. The measurement of credit impairment is based on the three-stage expected credit loss model described below in note (c) Impairment of financial assets.

*(a) Financial assets measured at fair value through other comprehensive income*

*Equity instruments*

Investment in equity instruments that are neither held for trading nor contingent consideration recognised by the Association in a business combination to which AASB 3 "Business Combination" applies, are measured at fair value through other comprehensive income, where an irrevocable election has been made by management.

Amounts presented in other comprehensive income are not subsequently transferred to profit or loss. Dividends on such investments are recognised in profit or loss unless the dividend clearly represents a recovery of part of the cost of the investment.

*(b) Items at fair value through profit or loss*

Items at fair value through profit or loss comprise:

- \* items held for trading;
- \* items specifically designated as fair value through profit or loss on initial recognition; and
- \* debt instruments with contractual terms that do not represent solely payments of principal and interest.

Financial instruments held at fair value through profit or loss are initially recognised at fair value, with transaction costs recognised in the income statement as incurred. Subsequently, they are measured at fair value and any gains or losses are recognised in the income statement as they arise.

Where a financial asset is measured at fair value, a credit valuation adjustment is included to reflect the credit worthiness of the counterparty, representing the movement in fair value attributable to changes in credit risk.

*Financial instruments held for trading*

A financial instrument is classified as held for trading if it is acquired or incurred principally for the purpose of selling or repurchasing in the near term, or forms part of a portfolio of financial instruments that are managed together and for which there is evidence of short-term profit making, or it is a derivative not in a qualifying hedge relationship.

*Financial instruments designated as measured at fair value through profit or loss*

Upon initial recognition, financial instruments may be designated as measured at fair value through profit or loss. A financial asset may only be designated at fair value through profit and loss if doing so eliminates or significantly reduces measurement or recognition inconsistencies (i.e. eliminates an accounting mismatch) that would otherwise arise from measuring financial assets or liabilities on a different basis.

A financial liability may be designated at fair value through profit or loss if it eliminates or significantly reduces an accounting mismatch or:

- \* if a host contract contains one or more embedded derivatives; or
- if financial assets and liabilities are both managed and their performance evaluated on a fair value basis in accordance with a documented risk management or investment strategy.

Where a financial liability is designated at fair value through profit or loss, the movement in fair value attributable to changes in the Association's own credit quality is calculated by determining the changes in credit spreads above the observable market interest rates and is presented separately in other comprehensive income.

*(c) Impairment of financial assets*

The Association applies a three-stage approach to measuring expected credit losses (ECLs) for the following categories of financial assets that are not measured at fair value through profit or loss:

- \* debt instruments measured at amortised cost and fair value through other comprehensive income;
- \* loan commitments; and
- \* financial guarantee contracts.

**Investments and other financial assets (continued)**

No ECL is recognised on equity investments.

*Determining the stage for impairment*

At each reporting date, the Association assesses whether there has been a significant increase in credit risk for exposures since initial recognition by comparing the risk of default occurring over the remaining expected life from the reporting date and the date of initial recognition. The Association considers reasonable and supportable information that is relevant and available without undue cost or effort for this purpose. This includes quantitative and qualitative information and also, forward- looking analysis.

An exposure will migrate through the ECL stages as asset quality deteriorates. If, in a subsequent period, asset quality improves and also reverses any previously assessed significant increase in credit risk since origination, then the provision for doubtful debts reverts from lifetime ECL to 12-months ECL. Exposures that have not deteriorated significantly since origination are considered to have a low credit risk. The provision for doubtful debts for these financial assets is based on a 12-months ECL. When an asset is uncollectible, it is written off against the related provision. Such assets are written off after all the necessary procedures have been completed and the amount of the loss has been determined. Subsequent recoveries of amounts previously written off reduce the amount of the expense in the income statement.

The Association assesses whether the credit risk on an exposure has increased significantly on an individual or collective basis. For the purposes of a collective evaluation of impairment, financial instruments are grouped on the basis of shared credit risk characteristics, taking into account instrument type, credit risk ratings, date of initial recognition, remaining term to maturity, industry, geographical location of the borrower and other relevant factors.

*(d) Recognition and derecognition of financial instruments*

A financial asset or financial liability is recognised in the balance sheet when the Association becomes a party to the contractual provisions of the instrument, which is generally on trade date. Loans and receivables are recognised when cash is advanced (or settled) to the borrowers.

Financial assets at fair value through profit or loss are recognised initially at fair value. All other financial assets are recognised initially at fair value plus directly attributable transaction costs.

The Association derecognises a financial asset when the contractual cash flows from the asset expire or it transfers its rights to receive contractual cash flows from the financial asset in a transaction in which substantially all the risks and rewards of ownership are transferred. Any interest in transferred financial assets that is created or retained by the Association is recognised as a separate asset or liability.

A financial liability is derecognised from the balance sheet when the Association has discharged its obligation or the contract is cancelled or expires.

*(e) Offsetting*

Financial assets and liabilities are offset and the net amount is presented in the balance sheet when the Association has a legal right to offset the amounts and intends to settle on a net basis or to realise the asset and settle the liability simultaneously.

**Property, plant and equipment**

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

**Property, plant and equipment (continued)**

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the Claremont Football Club Inc. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

**Impairment of non-financial assets**

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

**Interest-bearing loans and borrowings**

All loans and borrowings are initially recognised at the fair value of the consideration received less and directly attributable transaction costs.

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the effective interest method.

Gains and losses are recognised in profit or loss when the liabilities are derecognised.

**Trade and other payables**

These amounts represent liabilities for goods and services provided to the Claremont Football Club Inc. prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

**Employee benefits**

*Short-term employee benefits*

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

*Other long-term employee benefits*

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are measured at the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

*Defined contribution superannuation expense*

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

**Fair value measurement**

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

**Goods and Services Tax ('GST') and other similar taxes**

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

**Comparative Figures**

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current year.

**Going Concern**

The financial statements have been prepared on a going concern basis which contemplates the continuity of normal business activities and the realisation of assets and the settlement of liabilities in the ordinary course of business.

For the year ended 31 October 2024, the Club generated a Net Surplus of \$177,885 (2023: \$164,896) and had cash inflows from operating activities of \$53,139 (2023: \$263,587).

The Board has prepared a budget, which indicates that the Club will have sufficient cash flows to meet all commitments and working capital requirements for the 12 month period from the date of signing this financial report. On this basis the Board is satisfied that the going concern basis of preparation is appropriate.

**Note 2. Critical accounting judgments, estimates and assumptions**

The preparation of the financial statements requires management to make judgments, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgments and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgments, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgments and estimates will seldom equal the related actual results. The judgments, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

**Estimation of useful lives of assets**

Claremont Football Club Inc. determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

**Impairment of non-financial assets other than goodwill and other indefinite life intangible assets**

Claremont Football Club Inc. assesses impairment of non-financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to Claremont Football Club Inc. and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value-in-use calculations, which incorporate a number of key estimates and assumptions.

**Employee benefits provision**

As discussed in note 1, the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

**Redevelopment Activities**

In 2017, the Club completed redevelopment activities at Claremont Oval pursuant to an agreement with LandCorp whereby the parties agreed to the cancellation of the Club's lease, and granted freehold title of the Clubhouse land to the Club on a conditional use basis. Redevelopment Activities were funded by Landcorp, up to an amount of \$16.5m, and have not been reflected in this financial report.

As part of the redevelopment, and pursuant to an agreement between the Club, the Town of Claremont and the purchaser of the land immediately to the north of the Club's facilities, the Club was entitled to 81 car bays. In 2021, the construction of the 81 car bays in the basement of the building to the north of the Club's facilities was completed. The Club made a contribution (funded by Landcorp) of \$1m to the cost of their construction. The value of these car bays has not been reflected in this financial report.

**Maintenance Fund**

During 2018, the excess land to the North of the Club facilities was sold by the Government and \$1.5m of the proceeds was granted to the Club pursuant to the terms of a Trust Deed.

Under the terms of the Trust Deed, the Club is required to keep these proceeds, and any interest earned, in an auditable Trust Account. The funds held in the Trust Account (separate to the financial statements) may only be applied to the costs of repairing, maintaining, and renewing the Club's premises in accordance with an Asset Management Plan that has been approved by the Government.

During the year, \$107,456 was expended by the Club on such repairs and maintenance. Of this amount, no funds were sourced from the Trust Account, with the entirety of such repairs and maintenance being funded by operating cashflows. At year end, the closing balance of the Trust Account was \$1,601,716.



## INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF CLAREMONT FOOTBALL CLUB INC

### Qualified Opinion

We have audited the accompanying financial report, of Claremont Football Club Inc ("the Club"), which comprises the statement of financial position as at 31 October 2024, statement of changes in equity, the statement of profit or loss and other comprehensive income and the statement of cash flows for the year ended on that date, notes comprising a summary of significant accounting policies and other explanatory information, and the directors' declaration.

In our opinion, except for the matters described in the Basis for Qualified Opinion section of our report, the financial report of Claremont Football Club Inc is in accordance with the club constitution, including:

- (i) giving a true and fair view of the company's financial position as at 31 October 2024 and of its performance for the year ended on that date; and
- (ii) complying with Australian Accounting Standards – Simplified Disclosure Requirements, the Associations Incorporation Act 2015 (WA) and associated regulations.

### Basis for Qualified Opinion

#### Revenue Recognition

As is common for organisations of this type, it is not practicable for the Club to maintain an effective system of internal control over cash receipts and payments until their initial entry in the accounting records. Our audit relating to these items was therefore limited to the amounts recorded in the accounts.

#### Redevelopment Activities

We draw attention to Note 7 in the financial report with respect to the Club's redevelopment activities completed in 2017. The funds received and spent on these activities have not been accounted for in this financial report, as such our audit procedures have been limited to that presented in the financial report. As a result, we have not obtained appropriate audit evidence to provide a basis for an audit opinion on the redevelopment activities and the effect of these has not been determined on the financial performance, position and cash flows of the Club.

We conducted our audit in accordance with Australian Auditing Standards. Those standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance about whether the financial report is free from material misstatement. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the Club in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's *APES 110 Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

## Other Information

The directors are responsible for the other information. The other information comprises the information included in the Club's annual report for the year ended 31 October 2024, but does not include the financial report and our auditor's report thereon.

Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

## Auditor's Responsibilities for the Audit of the Financial Report

Our responsibility is to express an opinion on the financial report based on our audit. Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Club to express an opinion on the financial report. We are responsible for the direction, supervision and performance of the Club audit. We remain solely responsible for our audit opinion.

We communicate with the directors regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the directors with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

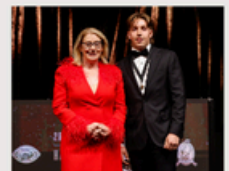

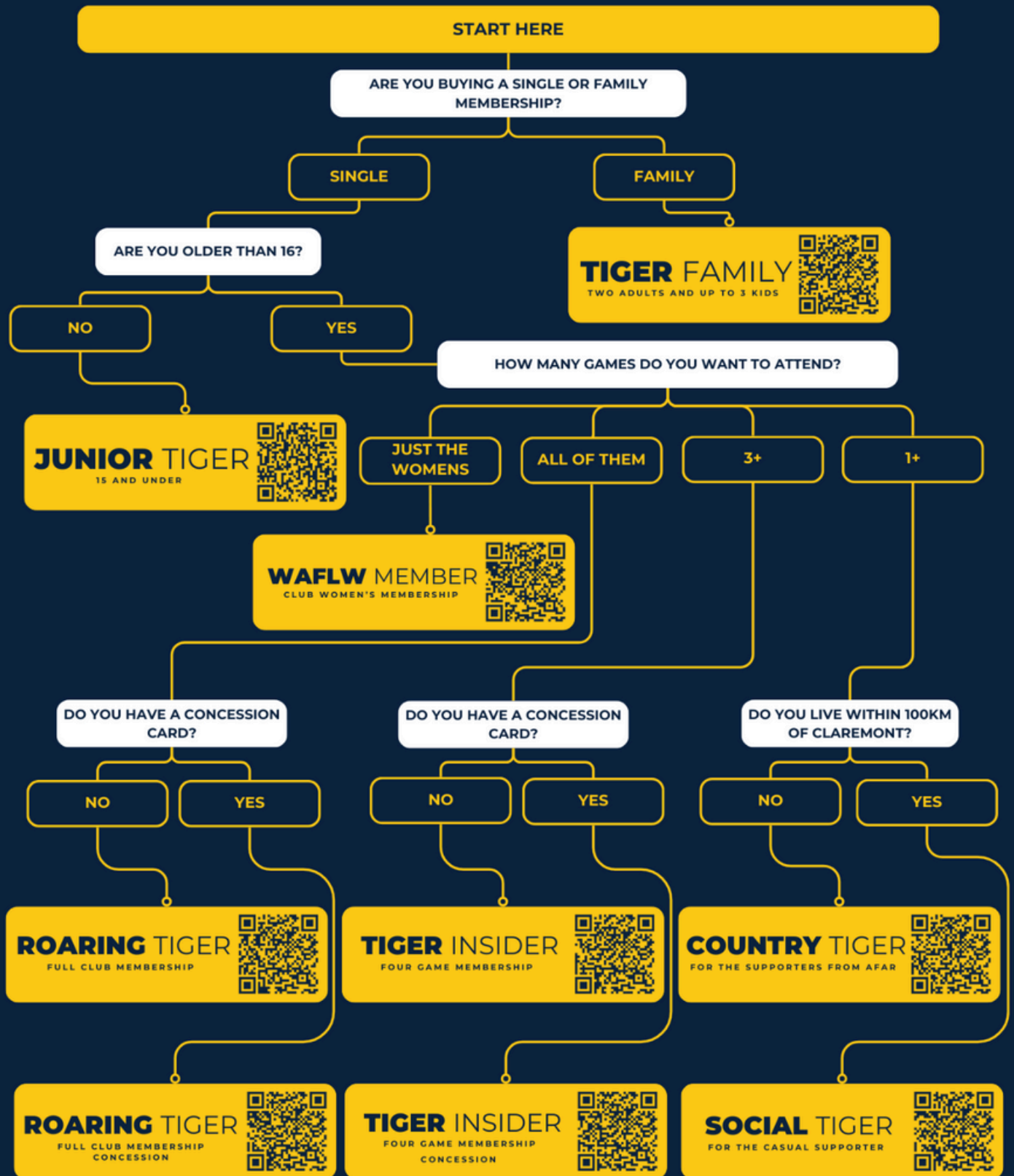
